AN ORDINANCE TO AMEND SECTION 2-133(a) OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA ENTITLED "OPERATIONS; procedures" (OF COUNCIL COMMITTEES) SO AS TO REQUIRE THAT ALL OFFICIAL REPORTS RECEIVED BY A COUNCIL COMMITTEE SHALL BE FILED WITH THE MINUTES OF THAT COMMITTEE; TO WAIVE CONFLICTING ORDINANCES AND CODE SECTIONS; AND FOR OTHER PURPOSES.

**WHEREAS**, official reports received by a council committee should be kept as a part of the official record of that committee; and

**WHEREAS**, although the legislative staff currently retains and files such reports with the minutes of the committee meetings, there is no requirement that this be done; and

**WHEREAS**, this requirement should be made a part of the operations and procedures of council committees.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, as follows:**

**Section 1:** Section 2-133(a) of the Code of Ordinances of the City of Atlanta which currently provides as follows:

*Record of actions.* Each standing committee of the council shall keep minutes of meetings, which shall include a complete written record of all its actions, and a record of the votes on any question. At least one electronic legible copy of such minutes of meetings shall be publishable in readable form on the official City of Atlanta website.

**Is hereby amended by adding the following sentence: "Also, all official reports received by the committee shall be retained and filed along with the minutes." so that when amended, said subsection shall provide as follows:**

*Record of actions.* Each standing committee of the council shall keep minutes of meetings, which shall include a complete written record of all its actions, and a record of the votes on any question. **Also, all official reports received by the committee shall be retained and filed along with the minutes.** At least one electronic legible copy of such minutes of meetings shall be publishable in readable form on the official City of Atlanta website.

**Section 2:** All ordinances and Code sections and parts of ordinances and code sections in conflict herewith are hereby waived to the extent of any such conflict.
