A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO ISSUE A TASK ORDER TO ARCADIS/BRINDLEY PIETERS & ASSOCIATES, A JOINT VENTURE, FOR FC-4906A, CITYWIDE ANNUAL CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES, REAL ESTATE PROFESSIONAL SERVICES FOR PARKS, GREENSPACE, TRAILS, GREENWAYS, AND CONSERVATION LAND ACQUISITIONS AND DONATIONS, ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY THOUSAND EIGHTY-EIGHT DOLLARS AND FOURTEEN CENTS (\$120,088.14), WITH ALL CONTRACTED WORK BEING CHARGED TO AND PAID FROM THE SPECIFIC ACCOUNT SEGMENT NUMBERS AS SET FORTH IN THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) did solicit bids for FC-4906A, Citywide Annual Contract for Architectural and Engineering Services; and

WHEREAS, the City Council adopted 09-R-1633 (“Resolution”) on September 21, 2009, and the Mayor approved the same on September 25, 2009 which authorized the Agreement for FC-4906A, Annual Contract for Architectural and Engineering Services, with Arcadis/Brindley Pieters & Associates, a Joint Venture (“Arcadis/Brindley”); and

WHEREAS, the base term of the Agreement is for Two (2) years with Three (3), One (1) year renewal options at the sole discretion of the City; and

WHEREAS, the Department of Parks, Recreation and Cultural Affairs is authorized under this Resolution to issue Task Orders pursuant to City of Atlanta Code of Ordinances Section 2-1111; and

WHEREAS, the Department of Parks, Recreation and Cultural Affairs requires real estate services for parks and green space acquisitions and donations, conservation and trail easement acquisitions and donations, and real estate tasks associated with the long-term management of acquired properties; and

WHEREAS, the Commissioner of the Department of Parks, Recreation and Cultural Affairs and the Chief Procurement Officer have recommended the issuance of a Task Order for Architectural and Engineering Services by Arcadis/Brindley Pieters & Associates, a Joint Venture, in an amount not to exceed One Hundred Twenty Thousand Eighty-Eight Dollars and Fourteen Cents (\$120,088.14).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his designee, is authorized to issue a Task Order to Arcadis/Brindley Pieters & Associates, a Joint Venture, for FC-4906A, Annual Contract for Architectural and Engineering Services for real estate professional services for parks, green



space, trails, greenways, and conservation land acquisitions and donations, in an amount not to exceed One Hundred Twenty Thousand Eighty-Eight Dollars and Fourteen Cents (\$120,088.14).

BE IT FURTHER RESOLVED, that the scope of work is attached hereto as Exhibit "A".

BE IT FURTHER RESOLVED, that the City Attorney is hereby directed to prepare the appropriate Task Order for execution by the Mayor.

BE IT FURTHER RESOLVED, that the Task Order will not become binding upon the City, and the City will incur no liability under it until it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk and delivered to Arcadis/Brindley, Pieters & Associates, a Joint Venture.

BE IT FINALLY RESOLVED, that all contracted work shall be charged to and paid from:
