A SUBSTITUTE ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO MAKE JESSE HILL JR DRIVE, S.E. A ONE WAY STREET BETWEEN ARMSTRONG STREET, S.E. AND GILMER STREET, S.E. WITH TRAFFIC BEING DIRECTED SOUTHBOUND; TO RESTRICT PARKING ON BOTH SIDES OF JESSE HILL, JR. DRIVE S.E. BETWEEN ARMSTRONG STREET, S.E. AND GILMER STREET, S.E.; AND FOR OTHER PURPOSES.

WHEREAS, the Fulton/DeKalb Hospital Authority d/b/a Grady Health System ("Authority") requested in 1996 that the City of Atlanta ("City") restrict traffic on Jesse Hill Jr. Drive, S.E. between Armstrong Street, S.E. and Gilmer Street, S.E. to reduce congestion at the entrance of the Grady Hospital; and

WHEREAS, Ordinance 96-O-0597 which was adopted by the Atlanta City Council on October 21, 1996 and approved per Section 2-403 of the City Charter, reclassified Jesse Hill Jr. Drive (formerly known as Butler Street, N.E.) between Armstrong Street and Gilmer Street to a transportation and entry plaza for the Authority; and

WHEREAS, only vehicles owned and operated by the Metropolitan Atlanta Rapid Transit Authority ("MARTA") are allowed access to the transportation and entry plaza; and

WHEREAS, the Authority has indicated that the restriction of general vehicular traffic along Jesse Hill Jr. Drive has created confusion for patients and visitors driving from the north of the hospital wishing to access the parking deck on the south side of the hospital campus; and

WHEREAS, the Authority is requesting that the City open Jesse Hill Jr. Drive between Armstrong Street and Gilmer Street to general traffic, and to prohibit parking on both sides of Jesse Hill Jr. Drive between Armstrong Street and Gilmer Street; and

WHEREAS, the request from the Authority to reclassify Jesse Hill Jr. Drive between Armstrong Street and Gilmer Street from a transportation and entry plaza to a local street is under the purview of the City Utilities Committee, and is now being acted on by separate legislation in that committee.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, as follows:


SECTION 1: That Jesse Hill Jr. Drive shall be made a one-way street with traffic directed southbound between Armstrong Street and Gilmer Street.

SECTION 2: That parking on both sides of Jesse Hill Jr. Drive is prohibited between Armstrong Street and Gilmer Street.



SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
