


MAYOR'S ACTION

AN ORDINANCE

AN ORDINANCE AUTHORIZING AND DIRECTING THE SPECIAL EVENTS MANAGER AND THE CHIEF OF STAFF TO WAIVE THE NINETY DAY DEADLINE AND ACCEPT THE OUTDOOR FESTIVAL PERMIT APPLICATION FOR THE 2011 KIRKWOOD SPRING FLING FESTIVAL AND TOUR OF HOMES; AND FOR OTHER PURPOSES.

WHEREAS, Sub-section 142-52(c)(2) of Article V. – Outdoor Festivals under Chapter 142 – Outdoor Events, requires that Outdoor Festival Application must be filed with the City at least 90 days prior to the date of the festival; and

WHEREAS, the City Code establishes that the Chief of Staff in the Mayor’s Office shall determine whether to grant an Outdoor Festival Permit, and that this determination shall be based on the criteria set forth in Article V - Outdoor Festivals; and

WHEREAS, as stated in the City Code, the Chief of Staff shall not accept a Festival Permit Application if it is filed later than 90 days prior to the date of the festival; and

WHEREAS, Kirkwood Neighborhood Organization (KNO) desires to hold its **2011 Kirkwood Spring Fling Festival and Tour of Homes on May 14th**; and

WHEREAS, Ryan Marosy, 2011 KNO President, took office in January this year and was not aware of the ninety day deadline; and

WHEREAS, with thousands of dollars committed, this is the biggest event for the Kirkwood Neighborhood, and the organizer has great difficulty in re-scheduling the event to a later date; and


WHEREAS, the area NPU has already approved the alcohol and festival permit; and

WHEREAS, Kirkwood Neighborhood Organization has requested a waiver of the 90 day deadline so that it can submit its Festival Permit Application at least 45 days prior to the event date.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Special Events Manager and the Chief Of Staff are hereby authorized and directed to waive the ninety day deadline requirement and accept the Festival Permit Application for the 2011 Kirkwood Spring Fling Festival and Tour Of Homes, said ninety day deadline being established in Sub-section 142-52(c)(2) of Article V. – Outdoor Festivals under Chapter 142 – Outdoor Events of Atlanta Code of Ordinances.

SECTION 2: That all ordinances and parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.
