A RESOLUTION AUTHORIZING THE CITY TO ACCEPT A GRANT FROM CBS OUTDOOR FOR THE PURPOSE OF ADVERTISING THE “HIRE ONE ATLANTA” PROGRAM SO THAT ADDITIONAL JOB GROWTH MAY BE ENCOURAGED AND EMPLOYMENT INCREASED THROUGH ENHANCED PUBLIC AWARENESS OF THE PROGRAM BY JOB SEEKERS AND EMPLOYERS; AND FOR OTHER PURPOSES.

WHEREAS “Hire One Atlanta” is a joint effort among Mayor Kasim Reed, the City of Atlanta and the Atlanta Business Chronicle to encourage each of the 150,000 businesses located in the City to hire one additional employee in order to decrease the ranks of the unemployed; and

WHEREAS, the *www.hireoneatlanta.org* website provides resources for Atlanta jobseekers and employers as well as spotlighting those employers who have contributed to the effort to reinvigorate Atlanta’s economy by creating new jobs; and

WHEREAS, wider public awareness of the “Hire One Atlanta” program will contribute to the fulfilling of its goals; and

WHEREAS, CBS Outdoor wishes to assist the “Hire One Atlanta” program in fulfilling its goals by providing advertising space that is available on already existing general advertising signs located in the City; and

WHEREAS, Section 1-102(7) of the City Charter gives the City the power to accept or refuse gifts, donations, bequests, or grants from any source for any purpose related to the powers and duties of the City and the general welfare of its citizens, on such terms and conditions as the donor or grantor may impose; and

WHEREAS, it is in the best interest of the City and the general welfare of its citizens that the grant of advertising space on already existing general advertising signs located in the City be accepted so information about the “Hire One Atlanta” can become more widely known to jobseekers and employers;

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES AS FOLLOWS:

Section 1: The Mayor is authorized to accept a grant from CBS Outdoor that provides advertising space on already existing general advertising signs located in the City for the sole purpose of advertising the “Hire One Atlanta” program on such terms and conditions as may be imposed provided however that no new general advertising signs are to be created or altered except in compliance with the City of Atlanta Sign Ordinance.
