

AN ORDINANCE BY COUNCILMEMBER IVORY YOUNG



AN ORDINANCE AUTHORIZING THE REIMBURSEMENT OF PARKING EXPENSES INCURRED BY MEMBERS OF BOARDS AND COMMISSIONS OF THE CITY OF ATLANTA IN CONNECTION WITH ATTENDING OFFICIAL MEETINGS OF SUCH BOARDS AND COMMISSIONS; AND FOR OTHER PURPOSES.

WHEREAS, appointed members of boards and commissions established by the City of Atlanta often are required to attend official meetings and hearing at City Hall; and

WHEREAS, such members of City of Atlanta boards and commissions incur expenses for parking in various lots and parking decks in the vicinity of City Hall when attending official meetings; and

WHEREAS, the Atlanta City Council desires to allow for the reimbursement of parking expenses for members of City of Atlanta boards and commissions in connection with their attendance at official meetings.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

Section 1. Appointed members of boards and commissions established by the City of Atlanta shall be reimbursed for expenses incurred in connection with parking in various lots and parking decks in the vicinity of City Hall when attending official meetings of such boards and commissions upon presentation of a receipt evidencing payment of parking expenses.

Section 2. That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
