AN ORDINANCE

**AN ORDINANCE TO WAIVE THE REQUIREMENTS OF SECTION 114-101(b) and 114-101(c) TO ALLOW FOR SUBMISSION OF THE PERSONNEL PAPER AND SUPPORTING DOCUMENTATION TO THE COUNCIL NO LATER THAN THE FIRST MEETING IN JUNE; AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 6-302 of the City Charter requires the Mayor to prepare and submit the proposed annual budget to the City Council no later than the first meeting in May; and

**WHEREAS**, in conjunction with the proposed budget, the administration may propose additional legislation, including but not limited to fee papers, reorganizations, and personnel actions; and

**WHEREAS**, the Atlanta City Council desired to have the greatest opportunity to consider and deliberate on legislation submitted in support of the Mayor's proposed budget, and so passed Ordinance 10-O-1241 requiring that legislation supporting the budget, including personnel papers, be submitted at the same time as the budget; and

**WHEREAS**, the City is currently considering modifications to the pension plans that could materially impact the FY 2012 budget; and

**WHEREAS**, in order to effectively deliberate and consider the potential changes to the pension plans and to avoid the possibility of an unintended immediate negative impact on positions in the City, the Atlanta City Council wishes to waive the requirements of 10-O-1241 until its first meeting in June.

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:**

**SECTION 1:** That the requirements of Section 114-101(b) and (c) are hereby waived to allow the submission of the personnel paper and supporting documentation by or at the first Atlanta City Council meeting in June of 2011.

**Section 2:** That this waiver is effective for the FY 2012 budget only.

**Section 3:** That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of any conflict.
