AN ORDINANCE TO AMEND THE 2011 GENERAL FUND BUDGET BY TRANSFERRING FUNDS FROM THE COUNCIL DISTRICT 3 AND POST 1 AT-LARGE ACCOUNTS TO THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT ACCOUNT FOR THE PURPOSE OF FUNDING THE COSTS ASSOCIATED WITH THE NOMINATION, DESIGNATION, AND POST-DESIGNATION PROCESS FOR THE PROPOSED SUNSET AVENUE HISTORIC DISTRICT; AND FOR OTHER PURPOSES.

WHEREAS, Department of Planning and Community Development staff to the Urban Design Commission (“UDC staff”) have been working with the residents of the Sunset Avenue neighborhood to create the Sunset Avenue Historic District and corresponding historic regulations; and

WHEREAS, Chapter 20 of the Atlanta Zoning Ordinance sets forth the process for the nomination, designation and post-designation of new historic districts; and

WHEREAS, the nomination process for historic districts includes, but is not limited to, mailed notice to each owner within the district proposed for nomination as well as published notice within a newspaper of general circulation; and

WHEREAS, if nominated by the Urban Design Commission, the designation process for historic districts includes, but is not limited to, mailed notice to each owner within the district proposed for nomination as well as published notice within a newspaper of general circulation; and

WHEREAS, if designated for historic protection by the City Council, the post-designation process for historic districts includes, but is not limited to, mailed notice to the owner of each property designated, mailed notice to various city and state officials and agencies, and the filing in the office of the clerk of the appropriate Superior Court a certificate of notification of designation as to each property designated; and

WHEREAS, the proposed Sunset Avenue Historic District is within the District 3 council boundaries and the council members for District 3 and Post 1 At-Large desire to contribute their respective district funds to help cover the actual costs associated with following the nomination, designation and post-designation process of historic districts can be substantial
