AN ORDINANCE TO EFFECTUATE ONE OF THE RECOMMENDATIONS MADE BY THE REVEREND JAMES ORANGE COMMISSION, SAID RECOMMENDATION BEING TO CHANGE THE NAME OF "OAKLAND CITY PARK" TO "REV. JAMES ORANGE PARK AT OAKLAND CITY"; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to Resolution 10-R-0223, adopted February 1, 2010 and approved February 9, 2010, a commission was created to determine an appropriate honor memorializing Reverend James Orange in the City of Atlanta (the Commission); and

WHEREAS, the Commission met, discussed, deliberated and held public hearings with regard to such an appropriate honor; and


WHEREAS, the Commission presented its recommendations and report to the Atlanta City Council which were reviewed and accepted by the Council pursuant to Resolution 10-R-1976, adopted November 1, 2010 and approved November 9, 2010; and

WHEREAS, one of the recommendations of the Commission is to change the name of "Oakland City Park" to "Rev. James Orange Park at Oakland City"; and

WHEREAS, the condition set forth in Section 2-2 of the City Code that a person so honored by a park renaming, shall have been deceased for a period of at least thirty (30) days has been met in that Rev. Orange passed away on February 16, 2008; and

WHEREAS, the City of Atlanta wishes to honor the service of Rev. James Orange by changing the name of "Oakland City Park" to "Rev. James Orange Park at Oakland City" to serve as a perpetual tribute to his personal and unyielding commitment to social justice for all; and

WHEREAS, City Code Section 138-8 (a) provides as follows: *Recognition of public interest.* The city recognizes that, from time to time, a certain individual or organization may make historical, cultural or other important contributions



to the city, the State of Georgia or the United States that merit recognition by renaming a Street or naming or dedicating a public place, such as a cross-walk, building, **park**, or other similar public place ("public place" or "public places") within the city in their honor. The city also recognizes that certain streets or public places within the city have already been named in honor of certain individuals or organizations that have made historical, cultural or other important contributions to the city, the State of Georgia or the United States. This section prescribes the procedures by which existing streets or public places within the city may be named or dedicated in honor of individuals and organizations, while preserving the integrity of those streets and public places that have already been historically connected or dedicated with the name of an individual or organization.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: All of the applicable procedures of City Code Section 138-8 shall be followed so as to cause the name of "Oakland City Park" to be changed to "Rev. James Orange Park at Oakland City".

Section 2: As required by City Code Section 2-2, such proposed renaming shall be placed on one agenda of the affected neighborhood planning unit(s), for informational purposes.

Section 3: All ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of any such conflict.
