A RESOLUTION EXPRESSING THE COUNCIL'S NON-SUPPORT OF ADOPTED SENATE BILL 79 AND REQUESTING THAT GOVERNOR DEAL NOT IMPLEMENT THE SUBSEQUENT LAW GIVING THE GOVERNOR THE AUTHORITY TO REMOVE AND APPOINT MEMBERS OF THE ATLANTA PUBLIC SCHOOL NINE MEMBER BOARD; AND FOR OTHER PURPOSES.

WHEREAS, the citizens of Atlanta and its representatives recognize that Governor Deal signed Senate Bill 79 into law; and

WHEREAS, this law usurps local authority and removes local government from the school system; and

WHEREAS, the current Board has not had ample time to address the issues that they are confronting.

NOW THEREFORE, BE IT RESOLVED that the City Council of Atlanta, Georgia, go on record as requesting that Governor Deal not implement the law.

BE IT FURTHER RESOLVED that the Municipal Clerk is directed to send (fax or Priority Mail) a copy of this resolution to the Governor, Nathan Deal, with all due haste.
