**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT BY AND BETWEEN THE CITY OF ATLANTA, GEORGIA AND THE ATLANTA DEVELOPMENT AUTHORITY FOR THE ADMINISTRATION OF THE EMPOWERMENT ZONE REVOLVING LOAN FUND AND THE EMPOWERMENT ZONE FAÇADE FUND.**

**WHEREAS**, by that certain Agreement By and Between The Atlanta Renewal Community CoRA, Inc. ("ACoRA") and ADA dated May 27, 2009, as amended (the "EZ RLF Agreement"), ADA agreed to perform certain services in furtherance of ISP Priority 1.4 (Reinstate Revolving Loan Fund), including but not limited to, marketing, underwriting and servicing loans to and for borrowers located in the formerly designated empowerment zone (the "EZ"); and

**WHEREAS**, by that certain Agreement By and Between ACoRA and ADA dated May, 27, 2009, as amended (the "EZ Façade Agreement"), ADA agreed to perform certain services in furtherance of ISP Priority 5.2 (Historic Westside Village/Martin Luther King Jr. Drive Corridor), including but not limited to, providing loans for façade and code correction improvements to commercial property owners located on the Martin Luther King Jr. Drive commercial corridor; and

**WHEREAS**, the City is successor to ACoRA to both the EZ RLF Agreement and the EZ Façade Agreement; and

**WHEREAS**, the Program ended on December 30, 2009 and was officially closed-out on June 30, 2010.

**WHEREAS**, the City and ADA desire to continue the administration and implementation of the EZ RLF Agreement and the EZ Façade Agreement and to memorialize the parties' understandings going forward with respect to the revolving loan fund subject of the EZ RLF Agreement (the "EZ RLF") and the revolving loan fund subject of the EZ Façade Agreement (the "EZ Façade Fund").

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA:**

**SECTION 1.** That the Mayor or his designee be and is hereby authorized to execute an Intergovernmental Agreement with the Atlanta Development Authority for the administration and implementation of the EZ RLF Agreement and EZ Façade Agreement.



**SECTION 2.** That the City Attorney is hereby directed to prepare an appropriate Intergovernmental Agreement for execution.

**SECTION 3.** The Intergovernmental Agreement shall not become binding on the City and the City shall incur no obligation or liability upon same until such amendment has been signed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form, and delivered to The Atlanta Development Authority.
