

**A SUBSTITUTE ORDINANCE BY
PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE AS AMENDED**

AN ORDINANCE AMENDING THE 2011 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS THE AMOUNT OF ONE-HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$125,000.00) DUE TO MODIFICATIONS IN GRANT FUNDS FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY (“ONDCP”) FOR THE CONTINUATION OF THE HIGH INTENSITY DRUG TRAFFICKING AREA (“HIDTA”) TASK FORCE AND CONTINUED DISRUPTION OF DRUG TRAFFICKING ORGANIZATIONS, AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Police Department (“Department”) has been an active participant in the High Intensity Drug Trafficking Area (“HIDTA”) task force responsible for disrupting and dismantling violent drug trafficking organizations in the Atlanta area for over ten years; and

WHEREAS, in 2005 Council and the Mayor approved resolution 05-R-0680, designating the Atlanta Police Department (“Department”) as the “pass through” agency for the HIDTA program funds, and authorizing the Mayor to execute all HIDTA agreements; and

WHEREAS, Ordinance #09-O-0764 amended the 2009 Intergovernmental Grant Fund Budget, Department of Police in the amount of two-million, eight-thousand, one-hundred nineteen dollars (\$2,008,119.00) for HIDTA Grant Award # G09GA0003A from the White House; and

WHEREAS, the White House supplemented Grant Award # G09GA0003A by adding an additional \$300,000.00, with no matching funds, for a total of \$2,308,119.00, and the 2009 Intergovernmental Grant Fund Budget was subsequently amended by Ordinance 09-O-1562 to reflect this supplement; and

WHEREAS, the White House has supplemented Grant Award # G09GA0003A by adding an additional \$2,661,925.00, with no matching funds, for a total of \$4,970,044.00, and the 2009 Intergovernmental Grant Fund Budget was subsequently amended by Ordinance 09-O-1999 to reflect this supplement; and

WHEREAS, the White House has supplemented Grant Award # G09GA0003A by adding an additional \$443,910.00, with no matching funds, for a total of \$5,413,954.00, and the 2009 Intergovernmental Grant Fund Budget was subsequently amended by Ordinance 10-O-0465 to reflect this supplement; and



WHEREAS, the Department wishes to accept the modification to the grant in order to remain in the HIDTA task force program and better disrupt and dismantle violent drug trafficking organizations in the Atlanta area.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION #1: That the Mayor be and is hereby authorized to accept a modification to Grant #G09GA0003A from the White House Office of National Drug Control Policy (“ONDCP”) in the amount of one-hundred twenty-five thousand dollars (\$125,000.00) with no matching funds, raising the grant to a new total of five-million, five-hundred thirty-eight thousand, nine-hundred fifty-four dollars (\$5,538,954.00).

SECTION #2: That the 2011 (Intergovernmental Grant Fund) Budget, Department of Police, is hereby amended as follows:


