AN ORDINANCE  
BY COUNCILMEMBER C. T. MARTIN

AS AMENDED BY CITY UTILITIES COMMITTEE

**TO DESIGNATE THE INTERSECTION OF BAKER STREET, NW BETWEEN PIEDMONT AVENUE, NW AND CENTENNIAL OLYMPIC PARK DRIVE, NW AS THE "HONORARY XERNONA CLAYTON WAY AND IDENTIFYING SPACE IN HARDY IVY PARK FOR THE "XERNONA CLAYTON PLAZA"; AND FOR OTHER PURPOSES.**

**WHEREAS**, pursuant to Resolution 10-R-0224, adopted February 1, 2010 and approved February 9, 2010, a commission was created to determine an appropriate honor for Ms. Xernona Clayton in the City of Atlanta; and

**WHEREAS**, the commission has met, discussed and deliberated with regards to an appropriate honor for this deserving local and international icon; and

**WHEREAS**, the commission is recommending several honors be bestowed upon Ms. Clayton which includes street toppers and the designation of park space at the Hardy Ivy Park; and

**WHEREAS**, pursuant to City Code Section 2-2, this ordinance shall be placed on the next agenda of the affected neighborhood planning unit(s), (NPU), for informational purposes.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS**, as follows:

**SECTION 1:** That Baker Street, NW between Piedmont Avenue, NW to Centennial Olympic NW be designated the "Honorary Xernona Clayton Way" and the Department of Public Works will approve the installation of street toppers at each corner of the intersection.

**SECTION 2:** The top Plaza of Hardy Ivy Park will be designated the "Xernona Clayton Plaza", the triangular park which begins at the northeast corner of Peachtree and Baker streets. This site will be used to honor Ms. Clayton and future honorees that maybe so honored.

**SECTION 3:** The changes are effective upon the Mayor's approval.

**SECTION 4:** All ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of any such conflict.
