A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AMENDMENT AGREEMENT NUMBER 1 WITH BROWN AND CALDWELL/DELON HAMPTON AND ASSOCIATES, CHARTERED, A JOINT VENTURE FOR FC-4906D, ARCHITECTURAL, ENGINEERING AND DESIGN SERVICES ON BEHALF OF THE ATLANTA POLICE DEPARTMENT, TO ADD THE ATLANTA POLICE DEPARTMENT AS AN ADDITIONAL USER AND TO ISSUE A TASK ORDER FOR THE CONSTRUCTION AND RENOVATION OF THE ATLANTA POLICE DEPARTMENT CRIME LAB, IN AN AMOUNT NOT TO EXCEED TWO HUNDRED TWENTY THOUSAND, SEVEN HUNDRED SIXTY-EIGHT DOLLARS AND ZERO CENTS (\$220,768.00); ALL WORK SHALL BE CHARGED TO AND PAID FROM 7701 (TRUST FUND), DEPARTMENT ORG 240101 (APD CHIEF OF POLICE), ACCOUNT 5413002 (BUILDING IMPROVEMENTS), FUNCTION ACTIVITY 1320000 (CHIEF EXECUTIVE), PROJECT AWARD 600234 (FEDERAL -RICO), FUNDING SOURCE.

WHEREAS, on September 21, 2009, the Atlanta City Council adopted and on September 25, 2009 the Mayor approved Resolution Number 09-R-1635 which authorized the Mayor to enter into contract with Brown and Caldwell/Delon Hampton and Associates, Chartered, a Joint Venture for a period of two (2) years with three (3) one (1) year renewal options at the sole discretion of the City; and

WHEREAS, the City of Atlanta ("City") entered into the original contractual agreement for FC-4906D, Architectural, Engineering & Design Services with Brown and Caldwell/Delon Hampton and Associates, Chartered, a Joint Venture, pursuant to Resolution 09-R-1635 on behalf for Departments of Watershed Management; Public Works; Planning and Community Development; Parks, Recreation and Cultural Affairs; and the Office of Enterprise Assets Management; and

WHEREAS, the Atlanta Police Department requires professional consulting services and to provide architectural and engineering, construction and renovation services for the design of an indoor firing range, a marijuana lab, and office space; and

WHEREAS, the Atlanta Police Department would like to issue a task order to Brown & Caldwell/Delon Hampton and Associates to provide Architectural and Engineering Construction and Renovation services to design a Crime Lab for the Atlanta Police Department in the existing building;

WHEREAS, this project is a TAD for the associated task order; and



WHEREAS, the Chief of Police and the Chief Procurement Officer recommend Brown and Caldwell/Delon Hampton and Associates, Chartered, a Joint Venture to provide architectural and engineering, construction and renovation services for the Atlanta Police Department Crime Lab in an amount not to exceed Two Hundred Twenty Thousand, Seven Hundred Sixty-Eight Dollars (\$220,768.00).

THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee is authorized to issue a Task Order to Brown and Caldwell/Delon Hampton and Associates, Chartered, a Joint Venture for FC-4906D, Architectural, Engineering & Design Services for Construction and Renovation Services for the Atlanta Police Department Crime Lab, in an amount not to exceed Two Hundred Twenty Thousand, Seven Hundred Sixty-Eight Dollars (\$220,768.00).

BE IT FINALLY RESOLVED, that all contracted work will be charged to and paid from 7701 (Trust Fund), Department Org 240101 (APD Chief of Police), Account 5413002 (Building Improvements), Function Activity 1320000 (Chief Executive), Project Award 600234 (Federal –Rico), Funding Source 69999 (Non-Capital).
