AN ORDINANCE TO TRANSFER ONE HUNDRED FOURY THREE THOUSAND FOUR HUNDRED FOURTY THREE DOLLAR AND SEVENTY CENT (\$143,443.70) FROM THE DISTRICT 9 COUNCIL MEMBER NON-DEPARTMENT EXPENSE ACCOUNT FUND TO THE DEPARTMENT OF PUBLIC WORKS TO BE USED TO CONSTRUCT SIDEWALKS, DRIVEWAYS CURBS AND GUTTERS FOR THE SIMMS AVENUE AND JOHNSON ROAD CURBING PROJECTS AND THE BOLTON ROAD/MARIETTA BOULEVARD INTERSECTION PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, residents and neighborhood associations within District 9 have made several request for needed sidewalks, driveways crubs and gutters to increase pedestrian safety; and

WHEREAS, the District 9 Councilmember desires to transfer funds from the District 9 Carry forward account to existing City of Atlanta Department of Public Works fund accounts to assist in funding the construction of the Simms Avenue, Johnson Road and the Bolton Road/Marietta Boulevard projects; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to amend the FY 2011 General Fund Budget as follows:
