



SECTION 1. An Ordinance to amend the Land Use Element of the 2008 Comprehensive Development Plan (CDP) so as to redesignate property that is located at a part of 668 Student Movement Blvd (formerly Fair Street) from the Medium Density Residential Land Use Designation to the High Density Residential Land Use Designation (Z-11-01) and for other purposes.

All that tract or parcels of land lying and being in Land Lot 109 of the 14<sup>th</sup> District of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.


