

AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ACCEPT A SUB-GRANT FROM THE DEPARTMENT OF HOMELAND SECURITY (DHS) FOR THE PURPOSE OF PROVIDING MAINTENANCE OF SPECIALIZED TECHNICAL RESCUE EQUIPMENT ON BEHALF OF THE DEPARTMENT OF FIRE RESCUE, AND TO AMEND THE 2011 (INTERGOVERNMENTAL GRANT FUND) DEPARTMENT OF FIRE BUDGET, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY-THOUSAND DOLLARS AND ZERO CENTS (\$20,000.00) AND FOR OTHER PURPOSES.

WHEREAS, the United States Department of Homeland Security (DHS) through the Georgia Emergency Management Agency (GEMA), provides state and local governments with critical funding to purchase and maintain specialized equipment and training; and

WHEREAS, the GEMA provides sub-grant funding directly to selected jurisdictions to address their specialized equipment, training, and preparedness; and

WHEREAS, the GEMA has awarded the City of Atlanta a sub-grant from the Department of Homeland Security's (DHS) Fiscal Year 2010, State Homeland Security Grant Program in the amount of twenty-thousand dollars and zero cents (\$20,000.00) for the purpose of providing maintenance of specialized technical rescue equipment; and

WHEREAS, the Department of Fire Rescue wishes to enter into the grant; and

WHEREAS, no matching funds are required with this grant.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: The Mayor or his designee is hereby authorized to accept a Department of Homeland Security Grant from the FY2010 State Homeland Security Grant Program in the amount of twenty-thousand dollars and zero cents (\$20,000.00), for the purpose of providing maintenance of specialized technical rescue equipment and for other purposes.

SECTION 2: That this grant from the Department of Homeland Security requires no matching funding from the City of Atlanta.



SECTION 3: That the 2011 (Intergovernmental Grant Fund) Budget, Department of Fire Rescue is hereby amended as follows:


