A RESOLUTION

AUTHORIZING THE CREATION OF A COMMISSION TO DETERMINE AN APPROPRIATE HONOR FOR FLIPPER TEMPLE AME CHURCH; AND FOR OTHER PURPOSES.

WHEREAS, Flipper Temple African Methodist Episcopal Church was founded by Reverend C.D. Thornton in January 1920 on Fair Street, SW; and,

WHEREAS, Flipper Temple AME Church has served as a cornerstone to the surrounding community, which includes the Atlanta University Center established in 1929; and,

WHEREAS, Flipper Temple AME Church has been integral to the Westside communities of Atlanta offering spiritual sustenance and guidance to all those in need; and,

WHEREAS, Flipper Temple AME Church is a vital part of the history of the surrounding university community.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES as follows:

SECTION 1: That a Commission is impaneled to determine an appropriate honor for Flipper Temple AME Church.

SECTION 2: The members of the Commission shall be appointed by the following individuals or organizations:

- One member by the Mayor;
- One member by the President of Council;
- One member each by the three paired Council groupings;
- One member by Neighborhood Planning Unit (NPU) T;
- One member by Morehouse College;
- One member by Spelman College;

- One member by Clark Atlanta University;
- One member by Interdenominational Theological Center;
- Three members by Flipper Temple AME Church Executive Board.
