A RESOLUTION AUTHORIZING THE MAYOR, TO ENTER INTO A HOUSING ASSISTANCE PAYMENTS (“HAP”) CONTRACT WITH EDGEWOOD CENTER LIMITED PARTNERSHIP IN AN AMOUNT NOT TO EXCEED TWO HUNDRED EIGHTY THREE THOUSAND ONE HUNDRED SEVENTY SIX DOLLARS AND NO CENTS (\$283,176.00) IN ORDER TO PAY RENTAL UNIT SUBSIDIES ON FORTY SIX (46) UNITS FOR INDIVIDUALS LIVING WITH AIDS/HIV AT THE EDGEWOOD CENTER COMPLEX PURSUANT TO THE SECTION 8 MODERATE REHABILITATION PROGRAM SPONSORED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) administers the Section 8 Moderate Rehabilitation Program to provide affordable housing through rental subsidies that benefits very low-income families and individuals; and

WHEREAS, the City of Atlanta has had a Housing Assistance Payment (“HAP”) contractual relation with Edgewood Center Limited Partnership to provide rental subsidies at the Edgewood Center Complex property in order to house 46 formerly homeless individuals living with AIDS/HIV, under the Section 8 Moderate Rehabilitation Program; and

WHEREAS, HUD has approved funding for a new HAP contract in the amount not to exceed Two Hundred Eighty Three Thousand One Hundred Seventy Six Dollars (\$283,176.00) in order to continue to provide affordable and standard housing for the aforesaid homeless individuals through May 2, 2012.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor be and is hereby authorized to enter into a Housing Assistance Payments Contract, with Edgewood Center Limited Partnership for forty six units at the Edgewood Center Complex in an amount not to exceed Two Hundred Eighty Three Thousand One Hundred Seventy Six Dollars (\$283,176.00).

BE IT FURTHER RESOLVED, that the contract term will end on May 2, 2012.

BE IT FURTHER RESOLVED, that all expenses shall be charged to and paid from Project, Task, Award, Expenditure, Owning Organization:
