


WHEREAS, Crown Plaza Hotel, located at 3377 Peachtree Road NE, Atlanta, Georgia, 30326 ("Crown Plaza Hotel") changed ownership; and

WHEREAS, as a result, Crown Plaza Hotel erroneously over-reported business license fee payments to the City of Atlanta for business tax calculation purposes for tax year 2008; and

WHEREAS, Crown Plaza Hotel has requested a refund in the amount of Eighteen Thousand, Two Hundred Eighty Nine Dollars and Forty Six Cents (\$18,289.46); and


WHEREAS, the Crown Plaza Hotel has submitted supporting documents to the Office of Revenue to substantiate its claim; and

WHEREAS, the Office of Revenue investigated the claim and has determined that the Crown Plaza Hotel is entitled to a refund in an amount not to exceed Eighteen Thousand, Two Hundred Eighty Nine Dollars and Forty Six Cents (\$18,289.46).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Chief Financial Officer is hereby directed to issue a refund to Crown Plaza Hotel in an amount not to exceed Eighteen Thousand, Two Hundred Eighty Nine Dollars and Forty Six Cents (\$18,289.46) for business license fees paid in error to the City of Atlanta for the tax year 2008.
