

A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE RENEWAL AGREEMENT NUMBER 2 WITH CADUCEUS OCCUPATIONAL MEDICINE FOR FC-6006007902, PRE-EMPLOYMENT PHYSICALS, ON BEHALF OF THE DEPARTMENT OF HUMAN RESOURCES, IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED TWO THOUSAND TWO HUNDRED TWENTY-NINE DOLLARS AND NO CENTS (\$402,229.00); ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS: 6002 (GROUP INSURANCE FUND) 5212003 (MEDICAL SERVICES PROVIDER) 220203 (DHR INSURANCE ADMINISTRATION) (\$298,000.00); 5051 (WATER AND WASTEWATER REVENUE FUND) 5212003 (MEDICAL SERVICES PROVIDER) 220203 (DHR INSURANCE ADMINISTRATION) (\$46,572.00); 5501 (AIRPORT REVENUE FUND) 5212003 (MEDICAL SERVICES PROVIDER) 220203 (DHR INSURANCE ADMINISTRATION) (\$39,428.00); 1001 (GENERAL FUND) 230203 (AFR FIRE EMERGENCY MEDICAL SERVICES) 5212001 (CONSULTANT SERVICES) (\$18,229.00); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") entered into an Agreement with Caduceus Occupational Medicine, for FC-6006007902, Pre-Employment Physicals, pursuant to Resolution 07-R-0079, which was adopted by the Atlanta City Council on January 17, 2007 and approved by the Mayor on January 22, 2007; and

WHEREAS, the Agreement is for a period of three (3) years, with two (2) one (1) year renewal options at the sole discretion of the City; and

WHEREAS, pursuant to Code Section 2-1206 of the City Code of Ordinances, the Chief Procurement Officer extended the Agreement for an additional 90 days, resulting in an expiration date of July 23, 2010; and

WHEREAS, Amendment Number 1 and Renewal Number 1 were entered into, pursuant to Resolution 10-R-1249, which was adopted by the City Council on July 6, 2010 and approved by the Mayor on July 14, 2010; and

WHEREAS, the option for Renewal Number 1 became effective on July 24, 2010, and expires on July 23, 2011; and

WHEREAS, the City further desires to exercise its second option to renew the Agreement for an additional one (1) year period, effective July 24, 2011 through July 23, 2012; and

WHEREAS, the Commissioner of the Department of Human Resources and the Chief Procurement Officer recommend the execution of Renewal Number 2 with Caduceus Occupational Medicine, in an amount not to exceed \$402,229.00.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to execute Renewal Number 2 with Caduceus Occupational Medicine, for FC-6006007902, Pre-Employment Physicals, in an amount not to exceed Four Hundred Two Thousand Two Hundred Twenty Nine Dollars and No Cents (\$402,229.00).

BE IT FURTHER RESOLVED, that this authorization is contingent upon adoption of funding as outlined herein in the FY2012 budget.


BE IT FURTHER RESOLVED, that the term of Renewal Number 2 will be for one (1) year, effective July 24, 2011 through July 23, 2012.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to prepare an appropriate Agreement for execution by the Mayor.

BE IT FURTHER RESOLVED, that the Agreement will not become binding upon the City and the City will incur no obligation or liability under it until it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk and delivered to the contracting parties.

BE IT FINALLY RESOLVED, that all contracted work shall be charged to and paid from: 6002 (Group Insurance Fund) 5212003 (Medical Services Provider) 220203 (DHR Insurance Administration) (\$298,000.00); 5051 (Water and Wastewater Revenue Fund) 5212003 (Medical Services Provider) 220203 (DHR Insurance Administration) (\$46,572.00); 5501 (Airport Revenue Fund) 5212003 (Medical Services Provider) 220203 (DHR Insurance Administration) (\$39,428.00); 1001 (General Fund) 230203 (AFR Fire Emergency Medical Services) 5212001 (Consultant Services) (\$18,229.00).
