A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO A COOPERATIVE PURCHASING AGREEMENT PURSUANT TO SECTION 2-1601 ET SEQ. OF THE CITY OF ATLANTA CODE OF ORDINANCES, UTILIZING WESTERN STATES CONTRACTING ALLIANCE CONTRACT NUMBER B27160 WITH DELL CORPORATION, FOR HARDWARE MAINTENANCE AND SUPPORT FOR THE DELL POWER EDGE SERVERS FOR THREE (3) YEARS WITH TWO (2) ONE-YEAR RENEWAL OPTIONS BEGINNING JULY 1, 2011 ON BEHALF OF THE DEPARTMENT OF INFORMATION TECHNOLOGY, IN AN AMOUNT NOT TO EXCEED EIGHTY-TWO THOUSAND, FORTY-TWO DOLLARS AND NINE CENTS (\$82,042.09) PER YEAR; ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS 1001 (GENERAL FUND) 050211 (IT NETWORK MANAGEMENT) 5222002 (REPAIR & MAINTENANCE-EQUIPMENT) 1535000 (DATA PROCESSING/MANAGEMENT INFORMATION SYSTEM); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") entered into a cooperative purchasing agreement with Dell Corporation ("Dell") utilizing Western States Contracting Alliance ("WSCA") Contract number B27160, for the Dell Hardware Maintenance and Support for the Power Edge servers for one (1) year pursuant to Resolution 10-R-1158 adopted by Atlanta City Council on June 21, 2010 and Approved as per City Charter Section 2-403 on June 30, 2010; and

WHEREAS, the Dell Hardware Maintenance and Support for the Power Edge servers is required to keep the City's mission-critical applications from becoming unavailable due to hardware failures; and

WHEREAS, pursuant to Article X, Division 15 Intergovernmental Relations of the City of Atlanta Code of Ordinances, the Chief Procurement Officer may procure supplies, services or construction items through contracts established by a public procurement unit outside the City; and

WHEREAS, the WSCA competitively procured an agreement with Dell in a manner consistent with the City of Atlanta Code of Ordinances for the goods and services necessary to support the City's mainframe applications; and

WHEREAS, the Chief Information Officer has identified WSCA contract number B27160 with Dell as an appropriate source for a cooperative purchase; and

WHEREAS, the Chief Information Officer and the Chief Procurement Officer recommend utilizing WSCA Contract number B27160 with Dell to cooperatively purchase Dell Hardware Maintenance and Support for the Power Edge servers.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized to enter into a cooperative purchasing

agreement with Dell, utilizing WSCA Contract number B27160, for the Dell Hardware Maintenance and Support for the Power Edge servers for three (3) years with two (2) one-year renewal options, in an amount not to exceed Eighty-Two Thousand, Forty-Two Dollars And Nine Cents (\$82,042.09) per year beginning July 01, 2011.

BE IT FURTHER RESOLVED, that all contracted work will be charged to and paid from Fund, Department, Organization and Account Numbers 1001 (General Fund) 050211 (IT Network Management) 5222002 (Repair & Maintenance-Equipment) 1535000 (Data Processing/Management Information System).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer in consultation with the City Attorney is directed to prepare the appropriate Agreement for execution by the Mayor.

BE IT FINALLY RESOLVED, that the Agreement will not become binding upon the City, and the City shall incur no liability upon same until contract has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to Dell.
