A RESOLUTION AUTHORIZING THE MAYOR TO ISSUE A TASK ORDER TO ARCADIS/BRINDLEY, PIETERS & ASSOCIATES, JOINT VENTURE, FOR FC-4906A, CITYWIDE ANNUAL CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES- DANFORTH ROAD SIDEWALK IMPROVEMENT PROJECT, ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS, IN AN AMOUNT NOT TO EXCEED NINETY NINE THOUSAND FIVE HUNDRED FOUR DOLLARS AND THIRTY NINE CENTS (\$99,504.39); ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM VARIOUS FUND DEPARTMENT ORGANIZATION ACCOUNT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) did advertise for FC-4906A, Annual Contract for Architectural and Engineering Services; and

WHEREAS, the City Council adopted 09-R-1633 (“Resolution”) on September 21, 2009, and the Mayor approved the same on September 25, 2009 which authorized the Agreement for FC-4906A, Annual Contract for Architectural and Engineering Services, with Arcadis/Brindley Pieters & Associates, a Joint Venture (“Arcadis/Brindley”); and


WHEREAS, the Department of Public Works requires professional consulting services for the revised design of the Danforth Road Sidewalk Improvement project; and

WHEREAS, the Commissioner of the Department of Public Works and the Chief Procurement Officer have recommended the issuance of a Task Order for Architectural and Engineering Services to Arcadis/Brindley, Pieters & Associates, JV, in an amount not to exceed Ninety Nine Thousand Five Hundred Four Dollars and Thirty Nine Cents (\$99,504.39).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his designee, is authorized to issue a Task Order to Arcadis/Brindley, Pieters & Associates, Joint Venture, for FC-4906A, for Architectural and Engineering Services, for the revised design of the Danforth Road Sidewalk Improvement project, in an amount not to exceed Ninety Nine Thousand Five Hundred Four Dollars and Thirty Nine Cents (\$99,504.39).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is hereby directed to prepare the appropriate Task Order for execution by the Mayor.

BE IT FURTHER RESOLVED, that the Task Order will not become binding upon the City, and the City will incur no liability under it until it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk and delivered to Arcadis/Brindley, Pieters & Associates, a Joint Venture.
