
THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:

SECTION 1. An Ordinance to amend the Land Use Element of the 2008 Comprehensive Development Plan (CDP) so as to redesignate property that is located at 3201 Atlanta Industrial Parkway from the Industrial Land Use Designation to the Office-Institutional Land Use Designation (Z-11-04) and for other purposes.

All that tract or parcels of land lying and being in Land Lots 261 & 267 of the 17th District of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.
