**A SUBSTITUTE ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ACCEPT A GRANT FROM THE NATIONAL ENDOWMENT FOR THE ARTS IN THE AMOUNT OF TWENTY FIVE THOUSAND DOLLARS AND NO CENTS (\$25,000.00) FOR THE PURPOSE OF FUNDING THE ARTSCOOL PROGRAM; TO AMEND THE 2011 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY FIVE THOUSAND DOLLARS AND NO CENTS (\$25,000.00); AND FOR OTHER PURPOSES.**

**WHEREAS**, the Department of Parks, Recreation and Cultural Affairs promotes art and cultural experiences throughout the City of Atlanta ("City"); and

**WHEREAS**, the ARTSCool program is an employment program developed by the Office of Cultural Affairs designed to provide young people with arts and job training, a salary and cultural experiences that enhance personal development; and

**WHEREAS**, the Office of Cultural Affairs has been awarded a grant from the National Endowment for the Arts for the ARTSCool program in the amount of Twenty Five Thousand Dollars and No Cents (\$25,000.00); and

**WHEREAS**, the Budget Commission of the City has recommended increasing estimated receipts in the 2011 (Intergovernmental Grant Fund) Budget by Twenty Five Thousand Dollars and No Cents (\$25,000.00).

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**SECTION 1:** That the Mayor or his designee is authorized to accept, on behalf of the City, a grant award from the National Endowment for the Arts for the ARTSCool program in the amount of Twenty Five Thousand Dollars and No Cents (\$25,000.00). The Mayor or his designee, on behalf of the City, is also authorized to execute any other documents required to accept the National Endowment for the Arts Grant.

**SECTION 2:** That the 2011 (Intergovernmental Grant Fund) Budget is hereby amended as follows:
