**AN ORDINANCE
BY CITY UTILITIES COMMITTEE**

AN ORDINANCE TO AMEND CHAPTER 154 (UTILITIES), ARTICLE II (WATER AND SEWER BILLING AND COLLECTIONS PROCEDURES), SECTION 154-26 (WATER AND SEWER APPEALS BOARD), OF THE CITY OF ATLANTA, CODE OF ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta Code of Ordinances (“Atlanta City Code) provides for the creation of a Water and Sewer Appeals Board (the “Board”) and Section 154-26 specifies the method of appointment for six members of the Board; and

WHEREAS, Ordinance 10-O-2116 increased the membership of the Board to seven members and a method of nomination must be provided for the selection of the seventh member.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

Section 1.

That Section 154-26(b)(1) shall be amended by deleting the current section and inserting in lieu thereof the following:

Six members will be nominated by the paired district councilmembers with the concurrence of the at-large councilmember and one member will be nominated by the president of council.

Section 2.

That all ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
