A RESOLUTION BY PUBLIC SAFETY & LEGAL ADMINISTRATION COMMITTEE AUTHORIZING THE MAYOR TO ENTER INTO A MAINTENANCE AGREEMENT WITH ORACLE AMERICA INC, PURSUANT TO THE STATE OF GEORGIA CONTRACT GS-35F-0009T, FOR DATABASE AND MAINTENANCE SUPPORT, ON BEHALF OF THE MUNICIPAL COURT OF ATLANTA FOR A PERIOD OF ONE (1) YEAR IN FY12, IN AN AMOUNT NOT TO EXCEED FORTY-FOUR THOUSAND THREE HUNDRED NINETY-FIVE DOLLARS (\$44,395); ALL COSTS TO BE CHARGED TO: FUND, DEPARTMENT, ACCOUNT, AND FUNCTION ACTIVITY: 1001 (GENERAL FUND), 190101 (MUNICIPAL COURT OPERATIONS), 5212001 (CONSULTANT PROFESSIONAL SERVICES), 2650000 (MUNICIPAL COURTS); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") entered into an agreement with Oracle America Inc, pursuant to GS-35F-0009T, for the purpose of purchasing database and maintenance systems; and

WHEREAS, Oracle America Inc. is experienced in the support of database and maintenance systems; and

WHEREAS, Oracle America Inc. has provided adequate database and maintenance support and can continue to provide ongoing database and maintenance support.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES that the Mayor be and is hereby authorized to enter into a maintenance agreement with Oracle America Inc., pursuant to GS-35F-0009T, for database and maintenance support, for a period of one (1) year in FY12, in an amount not to exceed forty-four thousand three hundred ninety-five dollars (\$44,395).

BE IT FURTHER RESOLVED, that the City Attorney or her/his designee be and is directed to prepare the Agreement for execution by the Mayor, and the Agreement shall be approved by the City Attorney or her/his designee as to form.

BE IT FURTHER RESOLVED, that the Agreement shall not become binding upon the City, and the City shall incur no obligation or liability hereunder until the same has been signed by the Mayor or her/his designee and delivered to Oracle America, Inc.

BE IT FINALLY RESOLVED, that all contracted work shall be charged to: 1001 (General Fund), 190101 (Municipal Court Operations), 5212001 (Consultant/Professional Services), 2650000 (Municipal Courts).
