


AN ORDINANCE AMENDING THE 2011 (WIA YOUTH JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWO MILLION TWENTY EIGHT THOUSAND TWO HUNDRED SEVENTY NINE DOLLARS (\$2,028,279.00) IN THE WORKFORCE INVESTMENT ACT WIA YOUTH FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL AREA YOUTH; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Workforce Investment Act ("WIA") is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupations skill for participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Department of Labor ("GDOL") has awarded the City of Atlanta ("City"), through the Atlanta Workforce Development Agency ("AWDA"), a grant in the amount of two million twenty eight thousand two hundred seventy nine dollars (\$2,028,279.00), to provide job training and other skills to local area youth; and

WHEREAS, AWDA recommends increasing receipts in the 2011 (WIA Youth Job Training Fund) Budget by two million twenty eight thousand two hundred seventy nine dollars (\$2,028,279.00) in the WIA Youth Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA , as follows:

Section 1: That the 2011 (WIA Youth Job Training Fund) Budget is hereby amended as follows:
