**A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXERCISE A RENEWAL OPTION IN CONTRACT FC-6008000004, WITH S & W SERVICES, INC., FOR WRECKER SERVICES FOR VEHICLES OVER TWO (2) TONS, ON BEHALF OF THE DEPARTMENT OF POLICE, ALL REVENUES FROM GENERATED UNDER THIS CONTRACT SHALL BE DEPOSITED INTO 1001 (GENERAL FUND), 000002 (DEPARTMENT), 3223002 (FEES, TOWING CONCESSION), 10000532 (CUSTOMER #).**

**WHEREAS,** the City of Atlanta ("City") approved and entered into contract FC-6008000004 ("Contract") with S&W Services, Inc., for Wrecker Services for vehicles over two (2) tons on behalf of the Department of Police ("Department") that is set to expire on July 10, 2011; and

**WHEREAS,** FC-6008000004 was approved through resolution 10-R-1060 by Council on 2 June 2008 and by the Mayor on 10 June 2008; and

**WHEREAS,** the revenues generated under the contract are deposited into 1001 (General Fund), 000002 (Department), 3223002 (Fees, Towing Concession), 10000532 (Customer #).

**WHEREAS,** FC-6008000004 includes two (2) one (1) year renewal options at the sole discretion of the City of Atlanta; and

**WHEREAS,** The Agreement became effective July 11, 2008 and expires July 10, 2011; and

**WHEREAS,** The City desires to exercise its first option to renew the Agreement for an additional one (1) year, effective July 11, 2011 through July 10, 2012; and

**WHEREAS,** the Department and the Chief Procurement Officer recommend exercising the renewal option with S & W Services, Inc., as stipulated on contract FC-6008000004, for wrecker services for vehicles over two (2) tons, on behalf of the Department of Police.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA,** that the Mayor or his designee be and is hereby directed to exercise the first of two (2) one (1) year renewal options of FC-6008000004 with S&W Services, Inc on behalf of the Department of Police, for wrecker services for vehicles over two (2) tons.

**BE IT FURTHER RESOLVED,** that the term of Renewal No. 1 shall be for a period of one (1) year, effective July 11, 2011 through July 10, 2012.

**BE IT FURTHER RESOLVED,** that the Chief Procurement Officer is directed to prepare an appropriate Agreement for execution by the Mayor.



**BE IT FURTHER RESOLVED**, that the extension of this contractual agreement shall not become binding on the City, and the City shall incur no liability upon the same until the renewal option has been executed by the Mayor and delivered to the contracting party.

**BE IT FINALLY RESOLVED**, that all revenue generated from these contractual agreements through wrecker sales shall be deposited into 1001 (General Fund), 000002 (Department), 3223002 (Fees, Towing Concession), 10000532 (Customer #).
