


WHEREAS, Resolution 11R0503 (“Legislation”) was adopted on by the Atlanta City Council on April 18, 2011 and approved without signature by operation of law on April 27, 2011; and

WHEREAS, the Legislation omitted the fund department organization and account number and dollar amount associated with consulting services and labor for the installation of wiring at the 72 Marietta Street location; and

WHEREAS, listing the correct Fund Department Organization and Account Number and funding amount does not increase the value of the contract or the total not to exceed amount of the Legislation; and
