A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AMENDMENT NO. 24 TO THE CENTRAL PASSENGER TERMINAL COMPLEX AND AGREEMENT LEASE WITH DELTA AIR LINES, INC. COVERING THE PERMANENT SURRENDER TO THE CITY OF ATLANTA OF APPROXIMATELY 477 SQUARE FEET OF SPACE ON CONCOURSE A AND APPROXIMATELY 436 SQUARE FEET OF RAMP AREA ON CONCOURSE A; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) and Delta Air Lines, Inc. (“Delta”), are parties to an Agreement and Lease of Premises dated March 22, 1977, as heretofore amended (“CPTC Lease”) covering the occupancy and use by the Airline of certain premises and facilities at Hartsfield-Jackson Atlanta International Airport (“Airport”); and

WHEREAS, approximately 477 square feet of Delta’s Concourse A apron level space and approximately 436 square feet of Delta’s Concourse A ramp area are needed to complete a needed electrical upgrades project and Delta is willing to surrender said space to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the Mayor is authorized to execute on behalf of the City of Atlanta Amendment No. 24 to the CPTC Lease under which Delta will permanently surrender approximately 477 square feet of Concourse A apron level space and approximately 436 square feet of Concourse A ramp space.

BE IT FURTHER RESOLVED that the City Attorney is directed to prepare said Amendment No. 24 for execution by the Mayor.

BE IT FINALLY RESOLVED that said Amendment No. 24 will not become binding on the City and the City will incur no obligation or liability under it until it has been executed by the Mayor and delivered to Delta Air Lines, Inc.
