



**ORDINANCE BY
PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE AMENDING THE 2011 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE BY DEDUCTING FROM ANTICIPATIONS AND APPROPRIATIONS THE AMOUNT OF FOURTEEN THOUSAND ONE HUNDRED SEVENTY-FOUR DOLLARS (\$14,174) DUE TO MODIFICATIONS IN GRANT FUNDS FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY (“ONDCP”) FOR THE CONTINUATION OF THE HIGH INTENSITY DRUG TRAFFICKING AREA (“HIDTA”) TASK FORCE AND CONTINUED DISRUPTION OF DRUG TRAFFICKING ORGANIZATIONS, AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Police Department (“Department”) has been an active participant in the High Intensity Drug Trafficking Area (“HIDTA”) task force responsible for disrupting and dismantling violent drug trafficking organizations in the Atlanta area for over ten years; and

WHEREAS, in 2005 Council and the Mayor approved resolution 05-R-0680, designating the Atlanta Police Department (“Department”) as the “pass through” agency for the HIDTA program funds, and authorizing the Mayor to execute all HIDTA agreements; and

WHEREAS, Council and the Mayor approved ordinance 10-O-1214, accepting and appropriating grant award #G10GA0003A and two modifications from the White House Office of National Drug Control Policy (“ONDCP”) in the total amount of four million, eight-hundred sixty-eight thousand, nine-hundred fifty-four dollars (\$4,868,954) to fund the Atlanta HIDTA task force; and

WHEREAS, ONDCP modified Grant Award # G10GA0003A by adding an additional seven-hundred fifty-six thousand, eight-hundred fourteen dollars (\$756,814) with no matching funds, to a new total of five million, six-hundred twenty-five thousand, seven-hundred sixty-eight dollars (\$5,625,768) and this modification was approved by Council and the Mayor through ordinance 10-O-1665; and

WHEREAS, ONDCP modified Grant Award # G10GA0003A by deducting fourteen thousand one hundred seventy-four dollars (\$14,174), with no matching funds, to a new total of five million, six-hundred eleven thousand, five hundred ninety-four dollars (\$5,611,594); and

WHEREAS, the Department wishes to accept the modification to the grant in order to remain in the HIDTA task force program and better disrupt and dismantle violent drug trafficking organizations in the Atlanta area.



THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS,
as follows:

SECTION #1: That the Mayor be and is hereby authorized to accept a modification to Grant #G10GA0003A from the White House Office of National Drug Control Policy (“ONDCP”) that deducts from the total grant award the amount of fourteen thousand, one hundred seventy-four dollars (-\$14,174) with no matching funds, thereby reducing the total grant budget to a new total of five million, six-hundred eleven thousand, five hundred ninety four dollars (\$5,611,594).

SECTION #2: That the 2011 (Intergovernmental Grant Fund) Budget, Department of Police, is hereby amended as follows:
