**AN ORDINANCE TO TRANSFER FUNDS IN THE AMOUNT OF \$20,000.00 FROM DISTRICT 6 COUNCIL MEMBER EXPENSE ACCOUNT TO CONTRIBUTE TO THE PIEDMONT PARK EXPANSION PROJECT; AND FOR OTHER PURPOSES.**

**WHEREAS,** the City of Atlanta has an operating agreement with the Piedmont Park Conservancy for the management and operation of Piedmont Park; and

**WHEREAS,** the Piedmont Park Conservancy (“PPC”) is a 501(c)(3) non-profit organization dedicated to the preservation and restoration of Piedmont Park (“Park”) located in Atlanta, Georgia, to the benefit of both the citizens of Atlanta and its many visitors; and

**WHEREAS,** part of the PPC’s mission is to support the City of Atlanta in developing, enhancing, rehabilitating, and maintaining the Park so that it remains a cultural and recreational resource in the City; and

**WHEREAS,** the Conservancy is currently undertaking an expansion project, themed “Breaking New Ground”, by increasing the park size by 53 acres, a 40 percent addition to the useable green space in Piedmont Park; and

**WHEREAS,** to date, the Conservancy has raised and invested \$41.25 million in constructing the new acreage, and is continuing with the Breaking New Ground Fund Raising Campaign with a goal of \$2.5 million; and

**WHEREAS,** funds are available in District 6 Council member’s expense account to assist in the implementation of the Piedmont Park Expansion Project; and

**WHEREAS,** the Council member has decided to contribute to the project.

**NOW, THEREFORE, the City Council of the City of Atlanta, Georgia hereby ordains, as follows:**

**SECTION 1:** That the Chief Financial Officer is authorized to remit payment to the Piedmont Park Conservancy (“PPC”) in the amount of \$20,000.00 for the Piedmont Park Expansion Project.

**SECTION 2:** That all payments shall be charged to and made from the following:
