A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH SCOTT AND SONS HOLDINGS, LLC. FOR 5221 ANNUAL CONTRACT FOR CLEAN-UP SEWAGE SPILLS INSIDE DWELLINGS, ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT, IN AN AMOUNT NOT TO EXCEED TWO HUNDRED THOUSAND DOLLARS AND NO CENTS (\$200,000.00); ALL CONTRACTED WORK WILL BE CHARGED TO AND PAID FROM FUND, DEPARTMENT ORGANIZATION AND ACCOUNT NUMBER 5051 (WATER & WASTEWATER REVENUE FUND) 170212 (DWM WASTEWATER COLLECTION) 5212001 (CONSULTING / PROFESSIONAL SERVICES) 4310000 (SANITARY ADMINISTRATION); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") did advertise for FC-5221, Annual Contract for Clean-Up Sewage Spills Inside Dwellings, on behalf of the Department of Watershed Management; and

WHEREAS, the Commissioner of the Department of Watershed Management has identified the need for services to clean inside dwellings affected by sewage spills; and


WHEREAS, the Commissioner of the Department of Watershed Management and the Chief Procurement Officer have recommended that FC-5221, Annual Contract for Clean-Up Sewage Spills Inside Dwellings, be awarded to Scott and Sons Holdings, LLC in an amount not to exceed Two Hundred Thousand Dollars and No Cents (\$200,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to enter into an Agreement with Scott and Sons Holdings, LLC for FC-5221, Annual Contract for Clean-Up Sewage Spills Inside Dwellings, on behalf of the Department of Watershed Management in an amount not to exceed Two Hundred Thousand Dollars and No Cents (\$200,000.00).

BE IT FURTHER RESOLVED, that the term of the Agreement will be for one (1) year with two (2) one (1) year renewal options at the City's sole discretion.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to prepare an appropriate Agreement for execution by the Mayor.

BE IT FURTHER RESOLVED, that the Agreement will not become binding on the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to Scott and Sons Holdings, LLC.



BE IT FINALLY RESOLVED, that all contracted work will be charged to and paid from 5051 (Water & Wastewater Revenue Fund) 170212 (DWM Wastewater Collection) 5212001 (Consulting / Professional Services) 4310000 (Sanitary Administration).
