


A RESOLUTION REQUESTING THAT THE MAYOR OR HIS DESIGNEE PROVIDE AN ANNUAL PERSONNEL FISCAL IMPACT STATEMENT OF THE CITY'S TOTAL PAYROLL FOR THE PURPOSE OF KEEPING THE ADMINISTRATION, CITY COUNCIL AND EMPLOYEES ABREAST OF THE PENSIONS' PAYROLL RATIO TO THE ACTUAL REQUIRED CONTRIBUTION (ARC); AND THE AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta is a creation of the State of Georgia under the authority of the Municipal Home Rule Act; and

WHEREAS, as a creation of the State of Georgia the City of Atlanta has the authority under the Municipal Home Rule Act to offer its employees a pension plan and certain other benefits; and

WHEREAS, under the Municipal Home Rule Act the City of Atlanta has created three separate pension funds for its police, fire and all other employees; and

WHEREAS, the City of Atlanta and its employees recently engaged in a struggle to reform the city's three pension plans which involved our employees making a significant sacrifice to get this reform behind us; and


WHEREAS, the compromise that was reached between the city and its employees could result in further increases to city employees should the City's Actual Required Contribution (ARC) to the pensions exceed thirty-five (35%) percent of City's total payroll; and

WHEREAS, employees are not in a position to control the number of new hires, pay adjustments and other compensation that may impact the total city payroll.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA; as follows:

SECTION 1: That the Mayor or his designee (CFO/HR Commissioner) will provide an - annual report to the Finance/Executive Committee with copies also being providing to the city pension boards and unions.

SECTION 2: That all resolutions and parts of resolutions in conflict herewith be and the same are hereby waived to the extent of the conflict.
