AN ORDINANCE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FY 2012 (INTERGOVERNMENTAL GRANT FUND – 2501) BUDGET IN THE AMOUNT OF FIVE THOUSAND DOLLARS AND NO CENTS (\$5,000.00) BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS FUNDS FOR THE GRANT FROM NATIONAL CENTER FOR CIVIC INNOVATION FOR THE PERFORMANCE REPORTING PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta’s Department of Watershed Management applied for and accepted a grant from the National Center for Civic Innovation Government authorized by City of Atlanta Resolution 10-R-1259; and
