A RESOLUTION AUTHORIZING THE MAYOR TO APPLY FOR, ACCEPT AND IMPLEMENT ALL GRANT FUNDS AND PROGRAMS FROM ALL STATE AND FEDERAL AGENCIES AND EXECUTE DOCUMENTS ASSOCIATED WITH SUCH GRANTS FOR PROJECTS AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT DURING THE 2012 FISCAL YEAR; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta, as owner and operator of Hartsfield-Jackson Atlanta International Airport ("Airport"), in its quest to gain additional funding for ongoing and innovative projects, desires to apply for offers of grants-in-aid for various projects at the Airport; and

WHEREAS, the timing and the amount of the various grant offers are accompanied by short deadlines for application, acceptance and the execution of grant documents, and failure to meet the deadlines means the opportunity to obtain such funding may potentially be lost; and

WHEREAS, it is prudent, therefore, to provide blanket authorization during the 2012 fiscal year for the Mayor to apply for, accept and implement grant funds and programs and execute documents associated with such grants in a timely manner to ensure that no opportunities for funding will be lost.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized to apply for, accept and implement grant funds and programs and execute documents associated with such grants during the 2012 fiscal year, pursuant to Code Section 2-910, for any Airport projects which are determined to be eligible for assistance, subject, if applicable, to the availability of matching funds in the Airport budget or as otherwise appropriated by the Atlanta City Council.

BE IT FURTHER RESOLVED that the Aviation General Manager, on a quarterly basis, shall provide the Transportation Committee with written notice of all grants applied for during the prior quarterly period for fiscal year 2012.

BE IT FINALLY RESOLVED that no Grant Agreement will become binding upon the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to the appropriate granting party.
