A RESOLUTION AUTHORIZING THE MAYOR TO APPLY FOR AND ACCEPT GRANT FUNDING FROM THE GOVERNOR'S OFFICE FOR CHILDREN AND FAMILIES UNDER THE JUVENILE ACCOUNTABILITY BLOCK GRANT (JABG) PROGRAM IN AN AMOUNT NOT TO EXCEED \$40,000.00 AND MATCHED BY THE CITY IN AN AMOUNT NOT TO EXCEED \$4,400.00 FROM DISTRICT 4 COUNCIL MEMBER EXPENSE ACCOUNT, TO DEVELOP AND IMPLEMENT PROGRAMS TO BENEFIT YOUTH IN DISTRICT 4; AND FOR OTHER PURPOSES.

WHEREAS, the young people in our City are critical to the future of the community and must be afforded opportunities to develop themselves into healthy and active members of society; and,

WHEREAS, such opportunities must be made available in the community by promoting youth activities that develop young people into healthy individuals by offering programs that promote healthy lifestyles and support positive social interaction; and

WHEREAS, the Governor's Office for Children and Families has federal funding available from the Juvenile Accountability Block Grant Program to fund youth programs designed to foster positive development of young people and prevent delinquent behavior to support growth of young people into productive and healthy adults.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, THAT

SECTION ONE: The Mayor is authorized to apply for and accept grant funding from the Governor's Office for Children and Families under the Juvenile Accountability Block Grant Program in an amount not to exceed \$40,000.00 to support programs for the benefit of youth in District 4.

SECTION TWO: Grant funds may be matched in an amount not to exceed \$4,400.00 from Account 1001. 030204. 5730004. 1110000 GEN. FUND, DISTRICT 4, COUNCIL MEMBER EXPENSE ACCOUNT.
