**A RESOLUTION OF THE ATLANTA CITY COUNCIL SUPPORTING THE INCLUSION OF THE MARTA PROPOSED MORELAND BUS RAPID TRANSIT (TIA-AT-020) PROJECT AND MARTA I-20 EAST, DOWNTOWN TO CANDLER ROAD PORTION (TIA-M-022) PROJECT IN THE REGIONAL ROUND TABLE (RRT) EXECUTIVE COMMITTEE (EC) PROJECT LIST; AND FOR OTHER PURPOSES.**

**WHEREAS**, The Executive Committee (EC) of the Regional Round Table (RRT) will be identifying projects on August 15, 2011 to include in its \$6.1B list of transit projects to be presented to the RRT; and

**WHEREAS**, there are no new transit projects south of I-20 included in the current \$6.5B list of projects from which the EC is to identify projects to be included in its \$6.1B Project List; and

**WHEREAS**, There were two transit projects on the Atlanta Region Unconstrained Project List (Attachment A), which, if included on the working constrained list of the EC, would give much needed transit service to the SE part of the region (Henry, Clayton South Dekalb), and to the I-20 corridor (South Dekalb), and South Atlanta; and

**WHEREAS**, These projects are: Moreland Bus Rapid Transit (TIA-AT-020) and MARTA I-20 East, Downtown to Candler Road portion (TIA-M-022), found on pages 10 and 36 of the Atlanta Region Unconstrained Project List ; and

**WHEREAS**, completion of the Marta Moreland Bus Rapid Transit (TIA-AT-020) and MARTA I-20 East, Downtown to Candler Road portion (TIA-M-022) projects would mitigate congestion, increase use of public transit, improve public safety, and enhance economic development activities in the South Metro (and entire) Region; and

**WHEREAS**, The Atlanta City Council supports inclusion of the Moreland Bus Rapid Transit (TIA-AT-020) and MARTA I-20 East, Downtown to Candler Road portion (TIA-M-022) in the EC \$6.1B Project List.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the City of Atlanta supports the inclusion of the proposed MARTA Moreland Bus Rapid Transit (TIA-AT-020) and MARTA I-20 East, Downtown to Candler Road portion (TIA-M-022) projects into the RRT Executive Committee (EC) \$6.1B Project List.

**BE IT FINALLY RESOLVED**, that the Municipal Clerk provide a copy of this adopted and approved legislation to all members of the Regional Round Table, including its Executive Committee (EC).
