AN ORDINANCE TO CALL AND CONDUCT AN ELECTION TO BE HELD ON NOVEMBER 8, 2011 FOR THE PURPOSE OF SUBMITTING THE QUESTION OF SUNDAY PACKAGE SALES BY RETAILERS OF MALT BEVERAGES, WINE, AND DISTILLED SPIRITS TO THE ELECTORS OF THE CITY OF ATLANTA FOR APPROVAL OR REJECTION; THE ELECTION SHALL BE CONDUCTED IN THE MANNER AUTHORIZED UNDER CODE SECTION 21-2-540; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, Senate Bill 10 was enacted during the 2011 session of the Georgia General Assembly and was signed by the Governor; and

WHEREAS, said Senate Bill which amended Code Section 3-3-7 of the Official Code of Georgia Annotated relates to the local authorization and regulation of sales of alcoholic beverages on Sunday; and

WHEREAS, a referendum must be held for the purpose of submitting the question of Sunday package sales by retailers of malt beverages, wine, and distilled spirits to the electors of the city of Atlanta.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

Section 1: The Council of the City of Atlanta hereby calls an election to be held on November 8, 2011 for the purpose of submitting the question of Sunday package sales by retailers of malt beverages, wine, and distilled spirits to the electors of the city of Atlanta for approval or rejection.



The ballot shall have written or printed thereon the words:

- YES **Shall the governing authority of the City of Atlanta be authorized to permit and regulate package sales by retailers of malt beverages, wine, and distilled spirits on Sundays between the hours of 12:30 P.M. and 11:30 P.M.?**
- NO

Section 2: All code sections, ordinances, and parts of code sections and ordinances in conflict herewith are hereby waived for the sole purpose of this ordinance only and shall otherwise remain in full force and effect.
