A RESOLUTION TO AMEND RESOLUTION # 11-R-0936 ADOPTED JUNE 20, 2011 AND APPROVED JUNE 29, 2011 WHICH ESTABLISHED “THE CITY OF ATLANTA ALCOHOL TECHNICAL ADVISORY GROUP II (ATAG II) FOR THE PURPOSE OF PERFORMING A COMPLETE AND COMPREHENSIVE REVIEW OF THE CITY OF ATLANTA’S ALCOHOL BEVERAGE LICENSING PROCESS AND THE ENFORCEMENT OF THE LAWS PERTAINING TO THE LICENSING, SALE AND REGULATION OF ALCOHOLIC BEVERAGES IN THE CITY OF ATLANTA” SO AS TO PROVIDE THAT ONE OF THE THREE REPRESENTATIVES FROM THE ALCOHOLIC BEVERAGE INDUSTRY SHALL BE APPOINTED BY THE NATIONAL ASSOCIATION OF LICENSING AND COMPLIANCE PROFESSIONALS AND FOR OTHER PURPOSES.

WHEREAS, Section 2 (10) of Resolution # 11-R-0936 establishing the ATAG II technical advisory group provides that three members of the group are to be representatives from the alcoholic beverage industry; and

WHEREAS, the resolution is silent with respect to the manner in which such industry representatives are to be appointed; and

WHEREAS, the National Association of Licensing and Compliance Professionals (NALCP) is a national organization formed to create a network of licensing compliance professionals working inside the United States restaurant and hospitality industry and has an interest in the laws and regulations which govern the alcoholic beverage industry; and

WHEREAS, NALCP desires to appoint one of the three representatives of the alcoholic beverage industry.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Item 10 of Section 2 of Resolution 11-R-0936 which currently provides as follows:

“three representatives (either owner, attorney or licensee) from the alcoholic beverage industry”



amended by adding thereto, the following:

“one of which shall be appointed by the National Association of Licensing and Compliance Professionals (NALCP)”

So that when amended said item shall provide as follows:

“10. three representatives (either owner, attorney or licensee) from the alcoholic beverage industry, one of which shall be appointed by the National Association of Licensing and Compliance Professionals (NALCP)”
