**AN AMENDED RESOLUTION BY**

**AUTHORIZING THE MAYOR TO ISSUE A NOTICE TO PROCEED WITH ARCADIS/BRINDLEY PIETERS & ASSOCIATES, A JOINT VENTURE FOR FC-4906A, ANNUAL CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES, FOR POST CLOSURE CARE AND LANDFILL MAINTENANCE FOR CITY OWNED LANDFILLS ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS, IN AN AMOUNT NOT TO EXCEED ONE MILLION SIX HUNDRED SEVENTY-SEVEN THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$1,677,215.00); WITH ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM THE FOLLOWING FUND, DEPARTMENT AND ACCOUNT NUMBERS: 5401 (SOLID WASTE SERVICES REVENUE FUND) 130541 (DPW LANDFILL CLOSURE AND POST CLOSURE) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 4560000 (CLOSURE AND POST CLOSURE CARE; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) did enter into an Agreement with Arcadis/Brindley Pieters & Associates, JV (“Arcadis/BPA”), for FC-4906A, Annual Contract for Architectural and Engineering Services, pursuant to Resolution 09-R-1633; and

**WHEREAS**, the base term of the agreement was for two (2) years with an option to renew for three (3) one (1) year periods at the City’s sole discretion, effective December 21, 2009 to December 20, 2011; and

**WHEREAS**, the Commissioner of the Department of Public Works requires Architectural and Engineering Services for post closure care and landfill maintenance on city owned landfills; and

**WHEREAS**, the Commissioner of the Department of Public Works and the Chief Procurement Officer have recommended the issuance of a notice to proceed with Arcadis/BPA, JV, for FC-4906A, Annual Contract for Architectural and Engineering Services for the Architectural and Engineering Services for post closure care and landfill maintenance on city owned landfills in an amount not to exceed One Million Six Hundred Seventy-Seven Thousand Two Hundred Fifteen Dollars (\$1,677,215.00); and

**WHEREAS**, the Department of Public Works will satisfy the financial obligation of FC-4906A, Annual Contract for Architectural and Engineering Services, for Post Closure Care and Landfill Maintenance of City Owned Landfills, using “phased funding”; and

**WHEREAS**, the Department of Public Works did appropriate funding for a portion of FY12 of the Agreement in an amount not to exceed One Million Two Hundred Thousand Dollars (\$1,200,000.00), with the remaining portion, if available, to be apportioned out of the FY13 budget.



**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor is authorized to issue a notice to proceed with Arcadis/BPA, JV, for FC-4906A, Annual Contract for Architectural and Engineering Services for post closure care and landfill maintenance on city owned landfills in an amount not to exceed One Million Six Hundred Seventy-Seven Thousand Two Hundred Fifteen Dollars (\$1,677,215.00).

**BE IT FURTHER RESOLVED**, that the portion of FY12 of the Agreement shall be funded in an amount not to exceed One Million Two Hundred Thousand Dollars (\$1,200,000.00) with the remaining portion of the Agreement to be appropriated and funded, if available, from the FY13 budget in an amount not to exceed Four Hundred Seventy-Seven Thousand Two Hundred Fifteen Dollars (\$477,215.00).

**BE IT FURTHER RESOLVED**, that the City Attorney be and is hereby directed to prepare the appropriate agreement for execution by the Mayor.

**BE IT FURTHER RESOLVED**, that the notice to proceed will not become binding upon the City and the City shall incur no obligation or liability hereunder until the same has been signed by the Mayor and attested to by the municipal clerk, and delivered to Arcadis/BPA, JV.

**AND FINALLY BE IT RESOLVED**, that all contracted work will be charged to and paid from the following Fund, Department and Account Numbers: 5401 (Solid Waste Services Revenue Fund) 130541 (DPW Landfill Closure and Post Closure) 5212001 (Consulting/Professional Services) 4560000 (Closure and Post Closure Care); and for other purposes.
