A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO PARTICIPATE WITH THE FRIENDS OF LITTLE NANCY CREEK PARK IN MAKING CERTAIN IMPROVEMENTS TO LITTLE NANCY CREEK PARK BY PROVIDING AN AMOUNT NOT TO EXCEED THIRTY THOUSAND DOLLARS (\$30,000.00) TOWARD CONSTRUCTION OF A PLAYGROUND AND PARKING LOT, WHERE ALL FUNDS SHALL BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS: 3501 (PARK IMPROVEMENT FUND) 140106 (PARK DESIGN) 5222003 (REPAIR & MAINTENANCE OTHER) 6220000 (PARK AREAS); AND FOR OTHER PURPOSES.

WHEREAS, in 2007 the City of Atlanta (“City”) purchased approximately five acres of property located at 4012 Peachtree Dunwoody Road; and

WHEREAS, the location was named Little Nancy Creek Park (the “Park”) in 2008 after the creek that bisects the site; and

WHEREAS, the Friends of Little Nancy Creek Park (“Friends of the Park”) is a 501(c)(3) non-profit organization dedicated to promoting and improving the Park through park workdays, volunteer opportunities, and social events; and

WHEREAS, the Friends of the Park along with the North Buckhead Civic Association have made significant improvements to the Park through cleanups, financial donations and other projects such as the building of a community garden; and

WHEREAS, in 2008, the Friends of the Park were awarded a Visioning Grant from Park Pride, in the amount of Twenty Five Thousand Dollars (\$25,000.00), which allowed for the development of a Master Plan for the Park; and

WHEREAS, as part of the Master Plan, a safe, long-lasting and unique playground and the installation of a parking lot are envisioned (the “Project”); and

WHEREAS, the Friends of the Park have raised One Hundred Thirty Thousand Dollars (\$130,000.00) toward the Project; and

WHEREAS, the Department of Parks, Recreation and Cultural Affairs desires to participate in the Project by providing funds to the Friends of the Park in an amount not to exceed Thirty Thousand Dollars (\$30,000.00); and

WHEREAS, the Friends of the Park will complete the Project through Park Pride, the organization charged with acting as a fiduciary agent for donated funds dedicated to park improvement, and coordinating volunteer services citywide for park improvement, beautification and maintenance; and



WHEREAS, the City is appreciative of the contributions of the Friends of the Park and finds that it is in the City's best interest to assist the Friends of the Park in completing this Project.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee, on behalf of the City, is hereby authorized to provide funds in an amount not to exceed Thirty Thousand Dollars (\$30,000.00) to the Friends of Little Nancy Creek Park to be used toward the construction of the Project at the Park.

BE IT FURTHER RESOLVED, that the City hereby accepts the contributions of the Friends of Little Nancy Creek Park.

BE IT FINALLY RESOLVED, that all funds shall be charged to and paid from the following Fund, Department, Organization, and Account Numbers: 3501 (Park Improvement Fund) 140106 (Park Design) 5222003 (Repair & Maintenance Other) 6220000 (Park Areas).
