**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A SUPPLEMENTAL LEASE AGREEMENT WITH THE UNITED STATES OF AMERICA FOR PARTIAL RELOCATION OF THE TRANSPORTATION SECURITY ADMINISTRATION FROM CONCOURSE E BOARDING LEVEL TO THE NORTH TERMINAL APRON LEVEL AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) owns and operates the Hartsfield-Jackson Atlanta International Airport (“Airport”); and

**WHEREAS**, the Transportation Security Administration (“TSA”) has been given the responsibility by the federal government to screen all airline passengers and their baggage; and

**WHEREAS**, in order to fulfill its responsibilities, TSA leased 2,182 square feet of office space on the boarding level of Concourse E at the Airport in 2008; and

**WHEREAS**, a portion of the space occupied by TSA on the boarding level of Concourse E is required for concession use; and

**WHEREAS**, the Aviation General Manager has identified like space on the apron level of the North Terminal as adequate replacement space (“Replacement Space”) for TSA; and

**WHEREAS**, the United States of America (“Government”) desires to enter into a Supplemental Lease Agreement with the City, which provides for the surrender of the Concourse E space and the leasing of the North Terminal space; and

**WHEREAS**, the Aviation General Manager and Chief Procurement Officer believe that it is in the best interest of the Airport and the City to enter into a Supplemental Lease with the Government and recommend the execution of such an Agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor is authorized to execute on behalf of the City a Supplemental Lease Agreement with the federal government, which shall contain the following terms, conditions, and provisions:

- 1) The permanent surrender of the Concourse E space to the City;
- 2) The leasing of the Replacement Space to the Government;
- 3) Official notice to proceed for the permanent move;



- 4) Outline of the scope of work and City's responsibilities; and
- 5) Affirm all other terms and conditions of the lease.

**BE IT FURTHER RESOLVED** that the City Attorney is directed to review and approve said Supplemental Lease Agreement (which will be prepared by the GSA) as to form.

**BE IT FINALLY RESOLVED** that said Supplemental Lease Agreement shall not become binding upon the City of Atlanta, and the City of Atlanta shall incur no obligation nor liability thereunder until same has been signed by the Mayor and delivered to the Transportation Security Administration.
