

**A RESOLUTION TO CORRECT RESOLUTION NUMBER 10R2147 ADOPTED BY THE CITY COUNCIL ON JANUARY 3, 2011 AND APPROVED BY THE MAYOR ON JANUARY 12, 2011 BY INSERTING A MISSING FUND DEPARTMENT ORGANIZATION AND ACCOUNT NUMBER AND DOLLAR AMOUNT; AND FOR OTHER PURPOSES.**

**WHEREAS**, Resolution 10R2147 (the "Legislation") was adopted by the Atlanta City Council on January 3, 2011 and approved by the Mayor on January 12, 2011; and

**WHEREAS**, the Legislation did not list all of the Fund Department Organization and Account Numbers and associated monetary amounts for Fiscal Year 2012; and

**WHEREAS**, it is the desire of the Department of Watershed Management to add Fund Department Organization and Account Number 5051 (Water & Wastewater Revenue Fund) 170212 (DWM Wastewater Collection) 5222002 (Repair & Maintenance-Equipment) 4310000 (Sanitary Administration) in an amount of One Hundred Eighty Thousand Dollars and No Cents (\$180,000.00) for fiscal year 2012 to the Fund Department Organization and Account Numbers and associated monetary amounts listed in Resolution 10R2147; and

**WHEREAS**, inserting the additional Fund Department Organization and Account Number and associated monetary amount does not increase the total monetary value of the legislation or contract.

**THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that Resolution 10R2147 be corrected by adding Fund Department Organization and Account Number 5051 (Water & Wastewater Revenue Fund) 170212 (DWM Wastewater Collection) 5222002 (Repair & Maintenance-Equipment) 4310000 (Sanitary Administration) for an amount of One Hundred Eighty Thousand Dollars and No Cents (\$180,000.00) for Fiscal Year 2012 to the listed Fund Department Organization and Account Numbers and associated monetary amounts wherever the funding sources are listed in the Legislation.

**BE IT FINALLY RESOLVED**, that all resolutions and parts of resolutions in conflict herewith be and are hereby waived to the extent of the conflict.
