THIS APPOINTMENT IS FOR A TERM OF FOUR (4) YEARS SCHEDULED TO BEGIN ON THE DATE OF THE APPROVAL OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to Resolution # 99-R-0606, the Board of Directors of the Atlanta Development Authority (ADA) was expanded from seven (7) members to nine (9) members by adding one (1) member nominated by the Fulton County Commission and one (1) member nominated by the City of Atlanta Board of Education so as to include the views of those entities and their constituents with regard to Atlanta Tax Allocation District projects; and

WHEREAS, also pursuant to said resolution, subsequent appointments of the nominee of the City of Atlanta Board of Education are to be made by the city council for a four year term; and

WHEREAS, there is currently a vacancy in the position of the appointee nominated by the City of Atlanta Board of Education; and

WHEREAS, the City of Atlanta Board of Education has nominated Ms. Brenda Muhammad to fill this vacancy on the Board of Directors of the ADA.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that Ms. Brenda Muhammad is hereby confirmed and appointed as the full council appointee to the Board of Directors of the Atlanta Development Authority for a term of four (4) years, scheduled to begin on the date of the approval of this resolution.
