AN ORDINANCE TO CORRECT CERTAIN OMISSIONS THAT WERE CONTAINED IN THE TEXT OF ATLANTA CITY COUNCIL ORDINANCE NUMBER 11-O-0861 ADOPTED BY THE ATLANTA CITY COUNCIL ON JUNE 20, 2011, THAT AMENDED ORDINANCE NUMBER 10-O-1556 TO INCLUDE THE ACQUISITION OF ADDITIONAL EQUIPMENT AND VEHICLES FOR VARIOUS DEPARTMENTS WITHIN THE CITY OF ATLANTA PURSUANT TO THE 1998A MASTER LEASE AND OPTION AGREEMENT BETWEEN THE CITY OF ATLANTA AND THE GEORGIA MUNICIPAL ASSOCIATION, INC.; AND FOR OTHER PURPOSES.

WHEREAS, on September 20, 2010, the Atlanta City Council did adopt and on September 29, 2010, the Mayor did approve Ordinance Number 10-O-1556 which authorized the Chief Financial Officer to amend the FY 2011 budget by adding to anticipations and appropriations in the amount of \$15,081,517 to be used for the acquisition of equipment for various departments within the City of Atlanta ("City") pursuant to the 1998A Master Lease and Option Agreement, dated June 1, 1998 (the "Agreement"), between the City and the Georgia Municipal Association, Inc. ("GMA"); and

WHEREAS, under the Agreement, the City, as agent to GMA, acquires the equipment to be leased and GMA makes payment to the City for the purchase using funds on deposit in the Equipment Fund after the equipment is accepted by the City and the City then makes Lease Payments to GMA for the equipment acquired; and

WHEREAS, at the time of the passage of Ordinance Number 10-O-1556, the equipment needed by the various City Departments included police cars, tractors, mowers and trucks as described in Exhibit "A" attached to Ordinance Number 10-O-1556; and

WHEREAS, the prioritization of the City's projects had changed since the passage of Ordinance Number 10-O-1556; and

WHEREAS, there were some additional savings from the original allocation of capital asset expenditures which the City desired to reallocate to additional fleet purchases; and

WHEREAS, on June 20, 2011, the Atlanta City Council did adopt and on June 29, 2011, the Mayor did approve Ordinance Number 11-O-0861 which amended Ordinance Number 10-O-1556 to allow excess funds in the amount of \$2,069,000 to be expended for fleet purchases for various departments; and

WHEREAS, it was subsequently discovered that Section 2 in Ordinance Number 11-O-0861, which amended the Fiscal Year 2011 Budget, did not reference the correct account numbers for all departments in Appropriations; and



WHEREAS, it is necessary to correct these omissions so that the fleet purchases can be made.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That Ordinance 10-O-1556 shall be amended to reflect the Fiscal Year 2011 Budget amendment as follows:
