A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE MAYOR'S OFFICE OF WEED AND SEED TO APPLY AND ACCEPT FUNDING IN THE AMOUNT OF THIRTY NINE THOUSAND FOUR HUNDRED NINETY FOUR DOLLARS AND NO CENTS (\$39,494.00) FROM THE STATE OF GEORGIA GOVERNOR'S OFFICE CHILDREN AND YOUTH JUVENILE ACCOUNTABILITY BLOCK GRANT FUND TO SUPPORT THE INTENSIVE SURVEILLANCE OFFICER PROGRAM AND TO PROVIDE MATCHING FUNDS IN THE AMOUNT OF TWENTY FIVE THOUSAND FOUR HUNDRED FORTY EIGHT DOLLARS AND NO CENTS (\$25,448.00); AND FOR OTHER PURPOSES.

WHEREAS, the State of Georgia, through the Juvenile Accountability Block grant, strengthens the juvenile justice system by increasing the capacity to develop youth competence, track juveniles through the system, provide enhanced options such as restitution, community service, victim-offender mediation, and other restorative justice sanctions that reinforce the obligations of an accountability-based juvenile justice system; and

WHEREAS, the City of Atlanta (the "City") has partnered with Fulton County Juvenile Court Probation Division to focus on offenders in the City of Atlanta;

WHEREAS, the City has been notified of the availability of funding for the Fiscal Year 2011-2012 to support the Intensive Surveillance Officer program to deter youth from re-offending through supervised and referred diversion program preventing them from committing additional crimes; and

WHEREAS, the City wishes to continue the Intensive Surveillance Officer Program and apply for the State of Georgia Juvenile Accountability Block Grant; and

WHEREAS, this grant will involve matching funds in the amount of Twenty Five Thousand Four Hundred Forty Eight Dollars and No Cents (\$25,448.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES that the Mayor is hereby authorized to apply for and accept a grant from the State of Georgia Juvenile Accountability Block Grant Fund in the amount of Thirty Nine Thousand Four Hundred Ninety Four Thousand Dollars and No Cents (\$39,494.00) for the purpose of funding the Intensive Surveillance Officer program.

BE IT FUTHER RESOLVED that the Mayor is hereby authorized to enter into any necessary related grant agreements.

BE IT FURTHER RESOLVED that matching funds involved for this grant award in the amount of Twenty Five Thousand Four Hundred Forty Eight Dollars and no cents (\$25,448.00) shall be charged to and paid from Fund 101 (General Fund) 040101 (Department/Organization) 5239004 (Service Grants) 1310000 (Function/Activity).
