A RESOLUTION TO AUTHORIZE THE DEPARTMENT OF PUBLIC WORKS, THE ATLANTA POLICE DEPARTMENT, THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, THE MAYOR'S OFFICE OF SPECIAL EVENTS, PIEDMONT PARK CONSERVANCY, ATLANTA BOTANICAL GARDEN, MIDTOWN NEIGHBORHOOD ASSOCIATION, ANSLEY PARK CIVIC ASSOCIATION, MORNINGSIDE-LENOX PARK NEIGHBORHOOD ASSOCIATION, VIRGINIA-HIGHLAND CIVIC ASSOCIATION, NPU-E AND NP- F CONDUCT A PARKING AND TRAFFIC CONTROL STUDY FOR THE NEIGHBORHOODS AND STREETS ADJACENT TO PIEDMONT PARK; AND FOR OTHER PURPOSES.

WHEREAS, Piedmont Park is the oldest and largest park in the Atlanta metropolitan region, visited by some 3 million people each year; and,

WHEREAS, As a result of the increased use of Piedmont Park, a 40% expansion was undertaken in 2008 – further increasing the number of people visiting the park.; and

WHEREAS, From April through mid-November of each year, Piedmont Park is host to over 50 festivals, events and concerts; and

WHEREAS, The volume of traffic created by these events places a great burden upon the surrounding neighborhoods of Midtown, Ansley Park, Morningside-Lennox Park and Virginia-Highland; and

WHEREAS, Adjacent streets are often overwhelmed by visitor parking where cars block driveways, pedestrian cross-walks and fire hydrants and violate City of Atlanta parking regulations; and,

WHEREAS, The City recognizes and welcomes the value of visitors to and patrons of the Park as well the importance of preserving the quality of life of those residents who live in proximity to the Park.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES, that the Department of Public Works, the Atlanta Police Department, the Department of Parks, Recreation and Cultural Affairs, the Mayor's Office of Special Events, Piedmont Park Conservancy, Atlanta Botanical Garden, Midtown Neighborhood Association, Ansley Park Civic Association, Morningside-Lennox Park Neighborhood Association, Virginia-Highland Civic Association, NPU-E and NPU-F shall conduct a parking and traffic control study for the neighborhoods adjacent to Piedmont Park.



BE IT FURTHER RESOLVED, that the study will make recommendations that include but are not limited to: defining the parking study area, identifying public and private parking facilities available for Piedmont Park visitors, identifying traffic congestion patterns and associated solutions.
