AN ORDINANCE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO TRANSFER FUNDS FROM THE DISTRICT 6 COUNCILMEMBER EXPENSE ACCOUNT AND THE PARK IMPROVEMENT TRUST FUND TO FUND THE PURCHASE AND INSTALLATION OF TWO FIXED POSITION CAMERAS IN PIEDMONT PARK IN AN AMOUNT NOT TO EXCEED TEN THOUSAND ONE HUNDRED FORTY SIX DOLLARS AND NO CENTS (\$10,146.00) TO BE CHARGED TO AND PAID FROM THE ACCOUNTS SET FORTH HEREIN; AND FOR OTHER PURPOSES.

WHEREAS, the Department of Parks, Recreation and Cultural Affairs (“DPRCA”) has proposed to install two fixed position cameras (“Cameras”) to improve public safety at Piedmont Park (“Park”); and

WHEREAS, one camera will be located behind the Piedmont Park Conservancy Community Center (“Community Center”) focusing on an open area, path and bench in the vicinity of the Community Center, and the other camera will focus on the parking lot abutting the Community Center; and

WHEREAS, the Cameras will be connected wirelessly to the City ONSSI NDVMS network video monitoring system; and

WHEREAS, the Cameras will be monitored by the City Police Department at the Zone 5 mini-precinct and the E911 Video Integration Center; and

WHEREAS, the cost of the materials, expenses, and installation for the Cameras will be Ten Thousand One Hundred Forty Six Dollars and No Cents (\$10,146.00); and

WHEREAS, the District 6 Councilmember (“Councilmember”) and the Commissioner of DPRCA (“Commissioner”) desire to fund the purchase and installation of the Cameras; and

WHEREAS, the Councilmember and the Commissioner desire to share in the expense of the Cameras equally by each contributing Five Thousand Seventy Three Dollars and No Cents (\$5,073.00).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to remit payments in an amount not to exceed of Ten Thousand One Hundred Forty Six Dollars and No Cents (\$10,146.00) from the District 6 Councilmember’s Expense Account in the amount of Five Thousand Seventy Three



Dollars and No Cents (\$5,073.00) and Park Improvement Trust Fund in the amount of Five Thousand Seventy Three Dollars and No Cents (\$5,073.00) for the cost of materials, expenses and installation of two fixed position Cameras with analytics in Piedmont Park.
